

**APPLICATION FOR NOMINATION FOR THE BOARD  
OF DIRECTORS FOR UNITED FINANCIAL CREDIT UNION**

POSITION TITLE: Board of Directors Member

POSITION RESPONSIBILITIES: The Board of Directors has the responsibility to maintain the general direction and control of the credit union. This includes directing the credit union in accordance with the Federal or State Credit Union Act, the bylaws, sound business practices, and other rules and regulations. The board is also required to perform additional actions and powers that might be required as laws and regulations change.

In addition the board is responsible for maintaining sound financial conditions; ensuring that there are adequate financial reserves to cover delinquent loans and other losses. The board must protect the credit union against unauthorized or illegal acts through bonding programs and the establishment of operational rules and procedures.

TERM: 3 years. Must attend monthly board meetings and any special or committee meetings.

DESIRABLE TALENTS AND QUALIFICATIONS: Directors must be members in good standing of the credit union. Candidates for the board of directors should be a member for at least one year, and should possess a dedication and commitment to the purpose of the credit union movement and to their credit union. An understanding of basic business procedures and an ability to read a balance sheet is also helpful. Persons with skills and talent in management, personnel affairs, data processing and budgeting could also be chosen to complement a well-rounded task force.

To be considered for this position, applicants should meet the basic requirements listed above. Applicants should detail their experience, knowledge, skills, and abilities in order to demonstrate how they meet these requirements.
